## CALL FOR PAPERS:

Corruption, and political corruption, is a complex and multi-layered social phenomenon, unwelcome, but characteristic of all organised societies, making it possible to acquire and hold on to illegal influence, power, and property, and potentially threatening the resilience and stability of the social system in times of crisis. Combined with other harmful factors, it can in extreme situations lead to social anomie.

Structural transformations accompany every change of regime and have a significant impact on the rise of corruption, which is a strategy frequently used to ensure the survival of all types of elites at a time of regime change.

Researching corruption, clientelism, and paternalism demands historical, political, social, legal, economic, and cultural context.

Corruption is an important topic in legal and legal-historical research, one in which we can examine shifts in legal thinking within various political and cultural contexts. Changes in legislation and practice, in particular involving public prosecutors' offices and courts, are on the one hand a fundamental, yet insufficiently researched issue. On the other hand, discussion of the form of the legal regulation of civil society – at the professional, legislative, and administrative level, and among the general public – is no less important to the history of law.

We primarily aim to examine the following thematic areas at the upcoming conference:

- Archival sources, theoretical and methodological approaches
- Corrupt practices in elections; the intensity and effectiveness of the use of corrupt practices as a tool of political battle, marketing, communication, and media image
- Assessing the continuity of patterns of corrupt behaviour among political and economic elites during transformations and changes of regime from a transnational perspective
- Focusing on various forms of corruption (for example, bribery, clientelism, and nepotism) as a tool for establishing new elites/preserving (saving) old elites during political and regime changes
- Anti-corruption discourse from a transnational perspective
- Corruption and clientelism as models of constructive and destructive behaviour, and as a security risk

The contributions presented that pass peer review will be published in an English-language collective monograph or in "Sborník archivních prací" (Collection of Archival Works) jointly published by the National Archives, Czech Republic and the Faculty of Arts, Charles University.
